OIR STORY

The Central Alberta Child Advocacy Centre is a not for profit organization rooted in the protection and recovery of today's most innocent and vulnerable – our children.

The CACAC was founded in response to a community crisis. An epidemic of youth suicides hit hard in Central Alberta, sparking overdue conversations and the need for a solution. A community coalition was formed with a goal to provide accessible mental health resources for adolescents, but the vision quickly expanded thanks to Sheldon Kennedy.

The idea of creating a Child Advocacy Centre, not just for Red Deer, but all of Central Alberta soon came to fruition. Conversations, connections and courageous commitment lead to what we have today: the Central Alberta Child Advocacy Centre.

A Centre aimed to provide wrap-around support to all children and families who need us. It takes courage for a child to come forward and share that someone has hurt them - we are here to listen without judgment, provide a safe and comfortable space for them to share their story, to provide guidance and support, and to ultimately give them back the chance of a healthy future.

The story of the CACAC continues today, and we are committed to changing the way that the people of Central Alberta overcome child abuse.





CST. Holly Porterfield, Forensic Investigator/Interviewer:

When the CACAC first opened, the expectation was to start slowly and that it would take a few months before our first interview – that was not the case. Since opening, the CAC has continued to see high caseloads month after month, demonstrating the operational need for additional forensic interview assistance. With support from the RCMP and The City of Red Deer, a second designated RCMP member was provided to the CAC.

Cst. Holly Porterfield has been a member of the RCMP for 12 years and previously worked at the Zebra Child Protection Centre (CAC for Edmonton Zone). Before her time at Zebra, Cst. Porterfield was working with youth and in schools for 6 years in Peace River and Wetaskiwin. Cst. Porterfield joined us in October 2019 and has been a much needed and welcome addition to our CAC family.

A Mental Health MOMENT

Last year we welcomed Nancy Patsula-Davis from Alberta Health Services as our first in-centre Mental Health Therapist. We are committed to providing victims of crime the opportunity to begin the healing process and become children again.

As the Centre grows and more children are seen, the more support that needs to be offered. In just one year there were

80 new referrals made. This is a large number and indicates the crucial need for mental health therapy throughout the journey of a child's healing.

Child abuse has many adverse effects, and can have a long-term impact on a child's mental health if not properly supported. The CACAC engages children in our play-therapy room and other child-friendly activities, allowing for the child to heal in a way that best suits their needs.

CASART:

The Central Alberta Sexual Assault Response Team

The Central Alberta Sexual Assault Response Team is a group of nurses specialized in sexual assault examinations. The group is available 24/7 providing support to RCMP, hospitals, physicians & patients across the Central Zone.

The team works collaboratively with the CACAC to ensure patients receive examinations & or referrals in a timely manner. Victim Advocacy

Providing comfort & support, community referrals, and helping families navigate the justice system.



Our Victim Advocacy Program has grown exponentially over the past year, going from 6 active Advocate Volunteers to 11, and from 3 families who accessed our Court Prep services to 173.

Our program continues to expand as we see more and children each month. The need for more services and resources is evident, and we have been able to introduce new methods of our advocacy services to accommodate:

Action Response for Complex Cases

The CACAC recognized a concern regarding an increase of high risk complex needs in relation to children and youth. The CAC ensures follow up regarding their mental health, safety and or addiction supports are being utilized, helpful and or meaningful to the youth.

Referrals and supports regarding mental health, harm reduction, safety (physical and emotional) are trauma informed/evidence based, client focused and are advocated for on behalf of those we support. Youth have the ability to speak up and share if the resources they utilize are helping and meaningful to them.

Support for Children & Families of Non-Chargeable Files

Even though a forensic interview has been conducted, some files may be determined not to be criminal or charges are not appropriate - *however*, those families still warrant support, assistance and advocacy.

Unique to the CACAC, we will continue to provide support, referrals, safety planning and/or follow up to ensure the victims of non-chargeable files feel supported during their healing journey. There are also victims who choose not to have police involvement (go forward with charges), yet want the support of the CACAC, mental health, CASASC, and other agencies which we refer to.









Court PREP

This year, thanks to many helping hands, we were able to create 2 court prep videos: Child & Youth versions Thanks in part to Red Deer Judiciary, we were able to create videos to show our children and youth what their day in court will look like

A-Volunteer Story Janelle Quaife, Victim Advocate

Since January 2019, I have been volunteering weekly with the Central Alberta Child Advocacy Centre as a Victim Advocate. I first heard about the centre when they opened and reached out to see how I could be involved. I have a two year Diploma in Early Childhood Development and have worked in a number of different areas including daycares, school age and group care. I have been working with McMan Youth, Family and Community Services for the past 5 years.

My role as victim advocate includes: providing family support through the entire process, court prep and court accompaniment. My main role is supporting families when they first attend the centre for a forensic interview; I provide emotional support, information and referrals to the families.

In addition to my advocacy work, I have also been involved in a number of fundraising events such as the pancake breakfast and gift wrapping booth at Bower Place.

The reason I wanted to become involved with the CACAC is that the mission and values of the advocacy centre align well with my own. I see first hand the value of the continued support that the CAC offers to the children, youth and families; I believe it is important that families are offered ongoing support throughout the process.

I admire the courage that it takes for a child or youth to report abuse and feel honored to be a positive part of their story through the work at the CACAC.

A Donor's Story Elaine Smith, Quilt Donor

I wasn't always an avid quilter; after inheriting supplies I taught myself how to quilt through online tutorials and learning from my own experience. In 2006 after retiring, I started with a group of close friends and we met monthly in my basement to quilt together and have some laughs. After organizing many Mystery Quilts for my girls, we decided as a group that we needed to something else to channel our passion for quilting - we were running out of people to gift our quilts to!

One day when I was online, the Red Deer Advocate popped up on my screen with an article about Central Alberta Child Advocacy Centre. After reading the article, I told my girls that this was now "my calling".

We still meet monthly, working on our choice of projects, but from creating quilt tops, to shopping with me for fabrics, my girls have always inspired me to keep creating for this very important organization.

We all need help at different times in our lives, especially when it comes to helping children in need. It really does take a village to raise a child, and it is so important for me to help where I can in that process. If I can provide these children with a small sense of comfort during a difficult time, then I'm doing what I was meant to do.

I delivered our first set of quilts in June of 2018 and continue to strive for donating as many quilts as I can every two to three months.

My inspiration for all of this is to give back; give as many hugs to these children as I possibly can, for as long as I can.





Courage Luncheon with **Dr. Peter Gregg**

CACAC EVENTS

The CACAC was given the great honor to be a part of Dr. Gregg's book launch for his novel *Lost Boy Found* in late October 2019. The idea of holding our first luncheon came when Dr. Gregg approached us after learning about our organization.

A child sexual abuse survivor himself, Dr. Gregg felt a sense of connection to our work. After years of silence, he was ready to share his experience in the hopes that it would help others.

The luncheon provided Dr. Gregg with the platform to share his story, reading a few excerpts from his novel and greatly impacting all those in the room with him that day.

Dr. Gregg and his wife, Anita, have graciously decided to donate all of the funds raised from his book sales. We are so thankful for Dr. Gregg's courage; his words have a profound effect on all those he meets, and we are grateful to be a small part in his incredible story.





On December 20th 2019, we launched our first 50/50 Cash Lottery! The 12-week campaign offered the chance to win up to \$200,000 guaranteeing a minimum prize of \$80,000. Thanks to the support of many community businesses and individuals, the lottery was a success!

On February 26th, we held another *One Day Challenge* (similar to the Dream Home Lottery in the previous year). This year's objective was higher than last, with a goal of selling **865 ticket packages**, recognizing the 865 children and youth we had supported up to that point. Through the use of social media, emails, calls and texts by our committee and volunteers, we not only reached our 24 hour goal, we exceeded it - selling a total of 981 Ticket Packages. This one-day initiative helped sell 25,713 individual tickets, totaling \$45,140 in sales!

The CACAC would like to thank all of the media sponsors involved, the dedicated committee community partners for allowing us to sell tickets at various venues and event, and all those whose purchased a ticket in support.

Third-Party **Events**

This year, over 75% of the funds raised for our Centre were through third-party events. These fundraisers were held on behalf of the CACAC, and have allowed our Centre to provide more support to more children, and have given us the opportunity to expand our programs.

From ball tournaments, to BBQs, photo-shoots golf tournaments, and galas, these third-party events raised \$310,000!

These summary financial statements do not contain all disclosures required by Canadian accounting standards for not-for-profit organizations. Reading the summary financial statements therefore is not a substitute for reading the audited financial statements of Central Alberta Child Advocacy Centre Ltd.

Management's Responsibility for the Summary Financial Statements

Management is responsible for the preparation of the summary financial statements in accordance with Canadian accounting standards for not-for-profit organizations.

Auditors' Responsibility

Our responsibility is to express an opinion on the summary financial statements based on our procedures, which were conducted in accordance with Canadian auditing standard (CAS) 810, Engagements to report on summary financial statements.

Basis for Qualified Opinion

In common with many not-for-profit organizations, Central Alberta Child Advocacy Centre Ltd. derives revenue from donations and fundraising activities, the completeness of which is not susceptible to satisfactory audit verification. Accordingly, verification of these revenues was limited to the amounts recorded in the records of Central Alberta Child Advocacy Centre Ltd. Therefore, we were not able to determine whether any adjustments might be necessary to donation and fundraising revenue, excess revenues over expenses, and cash flows from operations.

Qualified Opinion

In our opinion, except for the possible effects of the matter described in the Basis for Qualified Opinion paragraph, the financial statements present fairly, in all material respects, the financial position of Central Alberta Child Advocacy Centre Ltd. as at March 31, 2020, and its financial performance and its cash flows for the period ended March 31, 2020, in accordance with Canadian accounting standards for not-for-profit organizations.
